Whilst the Christmas season is now in full swing, everyone is thinking about celebrations. However, we started our celebrations a little earlier at TGSA. The school underwent a Section 5 Ofsted inspection on 2^{nd} and 3^{rd} November, and has been judged as 'Good' in all areas.

Peter Rock, Chairman of the Trust Board said that this was a "staggering achievement". Tudor Grange Samworth Academy joined the Trust in 2016 as a school in special measures. While the Trust has supported the school with initiatives and resources, Ofsted had not seen the improvement they desired until this inspection.

We have pulled together as a community, with strong staff and leaders and we have developed some key initiatives in reading, developing our through curriculum from early years right through to year 11 and introduced behaviour routines —all of which helped the school achieve the grading of 'GOOD'.

Jenny Bexon-Smith, the Chair of our Local Governing Body said, "we are delighted with this result and on behalf of the parents and community I would like to thank and praise the staff for all they do for our wonderful children."

Advice on Using E-scooters from Leicestershire Police

What is an e-scooter?

Electrical scooters (also known as e-scooters) come under the category of "powered transporters". This also covers a range of other personal transport devices which are powered by a motor.

"Powered transporters" fall within the legal definition of a motor vehicle under the Road Traffic Act 1988. Therefore, the rules that apply to motor vehicles, also apply to e-scooters.

As a motor vehicle, they must comply with various pieces of Road Traffic Legislation, including but not limited to:

- · driving with a licence
- driving/riding with insurance
- · driving/riding other than on a road
- · need to be taxed

It is not currently possible to get appropriate insurance for privately owned e-scooters, meaning it is illegal to use them on the road or in public spaces.

Rental e-scooter trials

Trials of rental e-scooters are taking place in the UK. Any person who uses a rental e-scooter on a public road or other public space, must comply with the relevant Road Traffic Legislation or they face potential prosecution.

Legal use of an e-scooter

It is legal to use an e-scooter on private land with the permission of the land owner.

In areas where a trial rental scheme is running, it is legal to use a rental e-scooter on a public road or cycle lane.

Enforcement

The most appropriate action for the circumstances will be given, these include:

- a Fixed Penalty Notice for no insurance, with a £300 fine and six penalty points
- a Fixed Penalty Notice for no driving licence, up to £100 fine and three to six penalty points

Rider behaviour

Police will also take action against rider behaviour, whether private or rental. Offences could include:

- riding on the footway: Fixed Penalty Notice and possible £50 fine
- using a mobile phone: £100 and six penalty points
- riding through red lights: Fixed
 Penalty Notice, £100 fine and possible
 penalty points
- drink driving offences: As with driving cars; court imposed fines, driving ban and possible imprisonment

If you are using an e-scooter in public in an anti-social manner, you can also risk the e-scooter being seized under section 59 of the Police Reform Act.

We would always recommend to wear safety protection such as a helmet when riding these vehicles, and to keep to the speed limit.
